I. Approval of the December 8, 2022 Minutes – approved via email

II. Graduate Dean's Report

A. *Update – Public History*

The Public History master's program has been unanimously and enthusiastically approved by the CCPE. The application is now live.

B. Academic Diversity Officer

Ellis introduced Gaskill as the new Academic Diversity Officer representing Graduate Studies & Academic Outreach. She will be working closely with Maha Younes, UNK Chief Diversity Officer.

C. Learning Designer (LD) Structure

The title of Instructional Designers has been changed to Learning Designers under a restructuring of duties to be completed this fall. The Learning Designers will work as a team instead of one assigned to each college to best utilize their specific skillsets to meet the needs of the department.

D. Graduate Student Association (GSA)

Ruff and Moore, student representatives on the Council, reported new developments of the Graduate Student Association. A virtual open house is planned for April 4 at 12:30-2 with the SVCAA speaking at the event. There will be breakout sessions, and all will be on zoom. More information will be forthcoming. The group will be meeting with Graduate Assistants on campus and there will be a social March 3rd at Brewed Awakenings. Recruitment for membership will begin with GA's and then all graduate students on and off campus. The GSA will give graduate students a voice and they will also vote for student representatives to serve on Graduate Council.

E. Student Representative

Adkins informed the Council that we currently need another student representative to serve on the Council. Please forward nominations to Adkins or Ellis.

F. Summer Funding

Ellis informed the Council that he is allocating summer funding including notes on what is being funded.

G. Tuition Rates

Ellis noted that other institutions have decreased their tuition rates which has had an impact on UNK's enrollment numbers. Ellis is currently exploring tuition rates across Nebraska so he can make recommendations. Professional programs, such as CDIS, are in high demand and have increased their tuition rates.

H. April Council Meeting

The April Graduate Council meeting coincides with Research Day so we will have some type of asynchronous meeting in April.

I. Research Day – April 13

Adkins reported that we are trying to include online students. The writing competition will work as normal where students' submissions are judged beforehand. There will be a physical poster for both online and in-person presentations. Judging happens during the assigned timeframe and zoom with online students in a breakout room. Oral presentations will be presented in a 3-minute timeframe. If the student is physically there; they will get up and do their oral presentation. Online students will be projected into the room. The oral presentations will be livestreamed to be all inclusive. The awards reception will also be livestreamed. Adkins circulated sign up sheets for judging the events.

J. 3MT

Information on the 3MT (3 Minute Thesis) was emailed on Monday and due February 28. Atkins is looking for judges to review those videos.

K. Graduate Student of the Year Award

Committee III will review these nominations and select the winner.

L. *MAGS Teacher of the Year*

Logan Johansen was submitted from Modern Languages to the MAGS teaching competition.

M. 4 + 1 – Accelerated Masters Program Update

This program would allow a student to use graduate hours to apply toward both the undergraduate and graduate degree. UNL and UNO have already started offering these. This may help with retention and motivated students can finish both an undergraduate and a graduate degree in 5 years. This is currently being considered at the undergraduate level and if approved, our office would assist with recommendations.

N. Committee II Chair

The Associate Dean has been leading this committee and will remain on the committee but a new chair needs to be named.

O. NU Advance

Adkins explained that NU Advance is the University of Nebraska System's course delivery platform for online, non-credit, and professional development offerings and is part of the five-year strategic plan. Faculty, staff, or any outside entity can develop courses to offer. Our Learning Designers and videographer can aid in building the courses. Students may be encouraged to move from non-credit to credit courses. We are currently in the pilot phase and there will be a robust marketing plan for the full launch in the fall.
