Therefore, any missed portion(s) of the course, for any reason, must be made up prior to the issuance of a waiver. A \$50 rescheduling fee will be assessed for every class, range time or driving time missed. On-street drive appointments are scheduled with the instructor outside of class times. Each student is provided 5 hours of driving time as part of this course. Students requiring more than 5 hours of driving will be charged \$50 per hour for the additional time needed. If a student misses a scheduled driving appointment, the rescheduling fee will be assessed.
