I. Approval of the March 13, 2025, Minutes – approved via email.

II. Graduate Dean's Report

Dean Ellis welcomed everyone to the meeting and thanked them for taking time to attend.

Dean Ellis reminded the council that the Graduate Student Association (GSA) will undergo a restructuring process. The GSA has drafted a proposed structure along with guidelines outlining how students may become involved in the organization. Chloe Dakan, the GSA representative, provided the council with an overview of the process behind the proposal. Discussions on this matter are still ongoing.

The council reviewed the proposed revisions to the Graduate College Bylaws. The revisions have already been approved at the campus level and will now advance to the system level for final approval. The vote to approve or reject the bylaws is currently open and will remain so until May 5. A public hearing, hosted by the Provost's Office, will take place via Zoom on April 15. All Graduate Deans will be in attendance.

Dean Ellis reminded the council that Student Research Day will take place on April 17. All are encouraged to attend and support the event by viewing the student poster presentations and oral sessions.

Sweeney sent a draft for a Dual-Listed Course Policy to the council. Discussion addressed expectations and necessary components for syllabi submitted to the CIM system for 4XX/8XXP courses. These courses are taught by the same instructor and occur in the same physical or online space. However, the expectations must be clearly differentiated between the two student groups.

Additional information was needed, so the revised policy will be emailed to the council members and voted upon via email.

The current Executive Members of the Grad Committee II will be stepping down from their positions. Sweeney led a discussion on potential candidates. Voting for the new Executive Members will take place after the Grad Council Elections conclude. Sweeney will send out the voting in May. Linda Johnson informed the council of some changes that the Nebraska Department of Education is making to endorsements. These changes include:

- Social Science 7-12 is now Social Studies 6-12
- Middle Level Social Science is now Middle Level Social **Studies** (no grade level change)
- The following endorsements change from grades 7-12 to 6-12:
 - English Language Arts
 - Geography
 - History
 - Political Science
 - Psychology
 - Secondary English
 - Sociology
 - Social Studies (was Social Science)

Students currently enrolled under the old name or grade level will have the new name and/or grade level on their teaching certificates.

For Graduate Council Action –Vote on the Dual-Listed Course Policy by email by Christopher Strickland/Torsten Homberger. Motion carried.

Course Numbering

Graduate courses are numbered at the 800- or 900-level. Courses numbered "800P" may have an undergraduate counterpart numbered at the 400-level or may be taught by non-graduate faculty. (These 400-numbered courses are listed in the undergraduate catalog.)

Courses numbered 800 (without the "P") are designated primarily for study beyond the bachelor's degree or towards a Master's degree. One half of a student's Master's degree must be numbered with 800 (non-P) courses.

Courses numbered at the 900-level are designated primarily for study beyond the Master's Degree.

Dual-Listed (P-Course) Course Policy

Dual-listed courses are usually courses that are offered concurrently for both undergraduate and graduate students. These courses are taught by the same instructor and occur in the same physical or online space. However, the expectations must be clearly differentiated between the two student groups.

1. Course Structure and Expectations

- **Dual-listed courses** with an undergraduate component must have distinct undergraduate and graduate components in terms of assessments. Graduate students will be held to higher academic standards than undergraduate students, in line with accreditation criteria.
- **Dual-listed courses** with an undergraduate component are designated with specific course numbering conventions:
 - Any new proposed P-level course must be a **400-level course** that is dual-listed with courses numbered **8xxP** for graduate credit.
 - Current dual-listed courses are expected to have an undergraduate 400-level course with an 800-level course, exceptions may be made for 300-level courses.
- Graduate students are expected to complete more challenging work, and their assessments will reflect higher expectations than those for undergraduates enrolled in the same course.

2. Syllabus Requirements

- The syllabus for dual-listed courses with an undergraduate component must include:
 - A clear distinction between undergraduate and graduate-level performance expectations.
 - o Specific assessment measures unique to graduate-level work.
 - A statement indicating that graduate students will be assessed at a higher level in both content complexity and intellectual rigor.

3. Enrollment Restrictions

- Graduate students cannot enroll in a dual-listed course if they have previously received credit for that course at the undergraduate level.
- A dual-listed course completed at the undergraduate level cannot be retroactively changed to a graduate-level course once it has been recorded on transcripts.

Graduate-Only Level Course Requirement

Courses selected for a student's Program of Study must include 50% or more of courses restricted to graduate students only (800- and 900-level courses), unless the Graduate Council permits the student to reduce this amount. 800-level courses designated with the letter "P" do not apply to this requirement.
