DHHS is the central agency involved with child abuse and neglect, this placement site give experience in collaborative working relationships with other systems such as school, medical, legal and other community, local and state agencies.

Student working with CPS may participate in individual planning, case management of ongoing cases, home visits and investigation of reports, team and community meetings. Student may also participate in casework which provides direct provision of service to parents, foster parents and children. Student might observe and experience what services are available in the in Adult Protective Services area.

Student working with disabilities will work with individuals and families. They will chair meetings, do home visits, type narratives and help around the office.

RD is the area within HHS that license and monitors foster and adoptive homes for children. Student will be involved in interviewing families for home studies, processing paperwork, conducting background checks, making recommendations and setting appointments with families wanting to become foster or adoptive homes.

Due to regulation of the agency students are more likely to observe for quite a long while before having responsibilities for client contact. This agency will require background checks.

This agency covers a lot of counties in the state and a considerable about of time will be spent traveling to provide mediation where the clients live.

Central Nebraska Veterans Home

The student will provide services ranging from presentence/predisposition, investigation, assessment, supervision, case management and placement. This placement is recommended only for students with Criminal Justice education/background.

This agency is a large regional agency with many programs, but the intern will work primarily with the Professional Partner Program (PPP). The philosophy of the Professional Partner Program (PPP) is strength based, family-centered, and acknowledges families as equal partners. The program promotes utilization of the least restrictive, least intrusive, developmentally appropriate interventions in accordance with the strengths and needs of the youth. Student will provide care coordination for children and adolescents with serious emotional disorders and their families. This is an excellent opportunity to observe multisystem that interface with the school system, medical system and legal system and with other social service providers.

Nebraska Department of Health and Human Services

Casey Smith 24 West 16th St. P.O. Box 218 (308) 385-6158

NDHHS is the state agency that offers a variety of programs for all age groups and needs. Student will work primarily in Resource Development (RD), Bridge to Independence (B2I), Child Protective Services (CPS) or Developmental Disabilities (DD).

RD helps license and monitor foster and adoptive homes for children in need of placement. Student will be involved in interviewing families for home studies, processing paperwork, conducting background checks, make recommendations and setting appointments.

B2I is a voluntary program that provides support for people between the ages of 19-21 a they go from foster care to adulthood. Student will be involved in working directly with a youth in providing advice, helping to access resources and help identify next steps to meeting the individual's goals.

CPS insures that children are in a safe environment. They also give families referral information. Students will observe intakes and assist with the intake and ongoing workers.

DD students will serve in the role of service coordinator. The student will be responsible for seeing that individuals with disabilities are receiving adequate services and funding through the state of Nebraska. They will go on home visits, attend various interdisciplinary meetings and help implement treatment plans and goals.

Due to regulation of the agency, students are more likely to observe for quite a long while before having responsibilities for client contact. This internship will provide education on the services this important agency has to offer. Almost all other agencies connect in some way with HHS services. This agency will require background checks.

Richard Young Hospital

Richard Young hospital is an inpatient psychiatric facility for individuals of all ages over the age of 14. They provide crisis mental health care, case management and stabilization services as well as provide group, family and individual psychotherapy, patient and family education. Students will be able to observe and be involved in caring for patients, meeting their basic safety needs, lead group-related to healthy behaviors, team-decision making processes, discharge planning, patient advocacy, strength-based treatment and holistic thinking within the context of a medical mental health facility.

The S.A.F.E. Center is a not-for- profit organization that serves clients who are victims of domestic violence or sexual assault. The S.A.F.E. Activities can include participation in support groups, observation of court activities and securing Orders of Protection, training on crisis telephone line, accompanying medical and legal advocates, individual work with client, gathering statistical information, and attendance at agency staffing and participating in community education programs. Due to the uncertain nature of reporting domestic violence, client interaction can be low.

Vocational Rehabilitation
