The University of Nebraska at Kearney offers the New Nebraskan Scholarship to all out-of-state undergraduate students so they will pay the in-state tuition rate. Non-Nebraska resident students will receive a discount to save up to \$30,600 on tuition over a 4-year period, matching in-state tuition rates. The Nebraska Promise covers undergraduate tuition costs after Pell grants and other grants and/or scholarships are taken into account. The Nebraska Promise will cover up to 15 credit hours per semester. Students must meet Title IV eligibility criteria.
