

2021-2022 FAFSA Verification

IRS Non-tax Filer Confirmation for Independent Student

We have received your 2021-22 Free Application for Federal Student Aid (FAFSA). Your FAFSA was selected for a process called "Verification." UNK is required by federal regulation to collect information to verify that the FAFSA is accurate. Any corrections made based on this documentation will be reported to you by the Federal Student Aid Center on an updated Student Aid Report.

You indicated on your 2021-22 FAFSA that you (and/or your spouse) did not file a 2019 federal income tax return with the IRS (form 1040). In order for our office to verify this you must submit an IRS Verification of Non-Filing Letter to our office. **If you and--if applicable--your spouse did not file, Verification of Non-Filing is needed from each of you.**

You have two options to submit verification of your non-tax filing status:

Option 1: Online Request:

1. Visit irs.gov, select "Get your Tax Record," select "Get Transcript Online."
2. Enter the Non-Filer's SSN, email address, filing status, account numbers for loan or credit card associated with their name, and mobile phone associated with their name.
3. Select "Verification of Non-Filing Letter" and in the Tax Year field, select "2019." If successfully validated, you will be able to view and print your IRS Verification of Non-Filing Letter.

Option 2: Filling out the 4506-T form:

1. Fill out box 1a through box 5 on the attached 4506-T form.
 - a. **Box 5: please list your NUID # as the "customer file number"**
2. Sign the bottom of the 4506-T form
3. Mail or fax the form to the appropriate Internal Revenue Service RAIVS Team location based upon where you lived on 12/31/2019. *The chart below will help you determine your correct IRS RAIVS Team.*

How to Submit your Verification of Non-Tax Filing Letter:

If you requested a Verification of Non-Tax Filing Letter via the 4506-T form, it may take 10-14 days for your letter to arrive. If you made an online request, the letter should appear immediately as a PDF document. Once received, **make a copy** for your records, mark through your social security number (cover it up), **write your name and NU ID# on it**, and submit the Verification of Non-Tax Filing Letter to our office. Preferred way to submit documents is to log into MyBLUE and access 'Document Upload' on the Financial Aid page under Related Documents. Other methods include fax, mail or in person.

Request for Transcript of Tax Return

a Return Transcript, which includes most of the line items of a tax return as filed with the IRS. A tax return transcript does not reflect changes made to the account after the return is processed. Transcripts are only available for the following returns: Form 1040 series, Form 1065, Form 1120, Form 1120-A, Form 1120-H, Form 1120-L, and Form 1120S. Return transcripts are available for the current year and returns processed during the prior 3 processing years. Most requests will be processed within 10 business days

b Account Transcript, which contains information on the financial status of the account, such as payments made on the account, penalty assessments, and adjustments made by you or the IRS after the return was filed. Return information is limited to items such as tax liability and estimated tax payments. Account transcripts are available for most returns. Most requests will be processed within 10 business days

c Record of Account, which provides the most detailed information as it is a combination of the Return Transcript and the Account Transcript. Available for current year and 3 prior tax years. Most requests will be processed within 10 business days

7 Verification of Nonfiling, which is proof from the IRS that you **did not** file a return for the year. Current year requests are only available after June 15th. There are no availability restrictions on prior year requests. Most requests will be processed within 10 business days

8 Form W-2, Form 1099 series, Form 1098 series, or Form 5498 series transcript. The IRS can provide a transcript that includes data from these information returns. State or local information is not included with the Form W-2 information. The IRS may be able to provide this transcript information for up to 10 years. Information for the current year is generally not available until the year after it is filed with the IRS. For example, W-2 information for 2016, filed in 2017, will likely not be available from the IRS until 2018. If you need W-2 information for retirement purposes, you should contact the Social Security Administration at 1-800-772-1213. Most requests will be processed within 10 business days

Caution: If you need a copy of Form W-2 or Form 1099, you should first contact the payer. To get a copy of the Form W-2 or Form 1099 filed with your return, you must use Form 4506 and request a copy of your return, which includes all attachments.

9 Year or period requested. Enter the ending date of the year or period, using the mm/dd/yyyy format. If you are requesting more than four years or periods, you must attach another Form 4506-T. For requests relating to quarterly tax returns, such as Form 941, you must enter each quarter or tax period separately.
