

BE READY FOR 2026-2027 FAFSA CHECKLIST FAFSA.GOV

If you are considered a **dependent student** (see right), your parent(s) or guardian(s) are considered a contributor to your FAFSA.

If you are considered an **independent student** and have a spouse, your spouse is considered a contributor to your FAFSA.

ITEMS YOU MAY NEED TO COMPLETE THE FAFSA

- ☐ Student and Contributor's 2024 Federal Income Tax Returns and all schedules (most tax return information will be pulled directly from the IRS database)
- ☐ Student and Contributor's FSA ID username and passwords
- ☐ Student and Contributor's email addresses
- ☐ Student and Contributor's date of birth and social security number
- ☐ Student and Contributor's savings/checking account balances
- ☐ Student and Contributor's investments (i.e. stocks, bonds, mutual funds, 529 plans, rental properties) excluding home and retirement
- ☐ Student and Contributor's current net worth of all contributor's businesses/farms
- ☐ Student and Contributor's child support received from the LAST complete calendar year
- ☐ Student and Contributor's Alien Registration Number/USCIS Number for eligible non-citizens
