Students are required to have a valid DMV-issued permit and a minimum of 10 hours driving practice before participating in this course. Registration will not be accepted without payment of either the down payment or full payment. Registration deadline is two weeks prior to the course start date or until the class is filled, whichever occurs first.

### **Cancellation/Refund Policy**

To receive a refund, written notification must be received more than 5 business days prior to the start of class.

The Nebraska Safety Center reserves the right to cancel class due to low enrollment, inclement weather or other unforeseen circumstances. In such cases, registrants will be given the option to choose a different class (dependent upon availability) or to receive a full refund.

• • • • • • • • • Attendance is critical to the student's success. Each class and driving appointment must be attended as scheduled. Outcome is performance-based.

#### Accommodations

If a student requires accommodations due to an ADA recognized disability, please contact the Nebraska Safety Center prior to registering. The Nebraska Safety Center does not have specialized training to assist persons with vehicle adaptation needs such as pedal extensions or hand controls, etc. If your teen has a medical condition or takes medication which affects their ability to operate a motor vehicle, please report that prior to registering. Medical clearance from a physician may be required to participate in this class.

#### Waivers

If the driver education student is UNDER 18 years of age at the time the course is completed, a waiver for the written and drive tests at the Nebraska DMV will be provided. If the student is 18 or older, a certificate of completion will be provided but the written and driving tests MUST be taken at the DMV Examining Office per state law. Driver's licensing staff, at their discretion, may require a drive test of ANY license applicant. The vehicle must be furnished by the applicant for the drive test at the DMV. The Safety Center will not provide a car for testing at the DMV.

## **CLASS INFORMATION**

This course conforms to the rules and regulations of the Nebraska DMV and exceeds the criteria established for insurance discounts. Nebraska DMV regulations require that, "Students must attend all course sessions and pass all examinations"; therefore, any missed portion(s) of the course, for any reason, must be made up for successful course completion. It is vital that students attend all classes because rescheduling may not be immediately available and will delay course completion for an undetermined amount of time. Students making up time missed will not be added to an already full course. A \$50 RESCHEDULING FEE WILL BE ASSESSED FOR EVERY ABSENCE.

Behind the wheel driving appointments are scheduled with the instructor separately from class times. Each student is provided 5 hours of driving time as part of this course. Students requiring more than 5 hours of driving may purchase additional driving time at \$50/hour.

## **BEHIND THE WHEEL**


• 5 hours of behind the wheel driving is required for in-person and online students.
