Rescheduling Fee

A change of course date may be possible, pending availability. This request must be made more than 5 business days prior to the start of the course. A \$50 rescheduling fee will be required after two course reschedules. There will be no refunds after the Monday prior to the course except for documented emergencies.

Cancellation Policy

Participant: To receive a refund, notification must be made more than 5 business days prior to the start of the course, less \$25 processing fee.

No refunds will be made to participants that cancel with less than 5 days notice, are late to a course, dismissed, counseled out, voluntarily leave, do not pass a written or riding evaluation, have previously rescheduled or missed a segment of either course.

Nebraska Safety Center: Courses may be canceled without notice due to inclement weather, lack of registrations, or other unforeseen problems. In such cases, participants will receive a full refund or may reschedule for a new course date.

BASIC RIDER COURSE (BRC)

Duration: 2 Day **Cost:** \$275

Structure:

Approximately 5 hours of classroom instruction and 10 hours of practical riding

Eligibility:

Participants must be at least 16 years old with a valid Provisional Operator's Permit (POP) or Operator's Permit. Riders aged 16-18 require a parental waiver.

Schedule:

Courses are available from March through October

Benefits:

Successful completion waives the DMV written and road tests, qualifying rider for the motorcycle endorsement "M" on their operator's license.

BASIC RIDER COURSE (BRC2)

Duration: 1 Day **Cost:** \$150

Structure:

Approximately 3 hours of classroom instruction and 5 hours of range practice.

Eligibility:

Open to riders aged 19 and older with at least one year of riding experience.

Schedule:

Offered on select dates from May through October.

Benefits:

Completion waives the DMV written and road tests, facilitating the addition of the "M" endorsement to your license.

We will send an email two weeks prior to your course that will include: course information and directions to our range, parental waiver (required if you are under 19), and a unique link to the required eCourse. The MSF and DMV require successful completion of the eCourse before attendance of your selected course. The eCourse is included in your class fees; be sure to wait for the email and use the link provided.



REGISTER NOW

REQUIREMENTS

- Be at least 16 years old with a valid Operator's License. A parent, or legal guardian, **MUST** sign required waiver for riders who are under 19.
- Be capable of controlling a motorcycle, including a good sense of balance, and possess the ability to ride a bicycle.
- Attend **ALL** on-cycle and classroom sessions, and pass both the knowledge and riding skills evaluation.
- Know that the instructor has the final authority in determining if a participant shall be permitted to participate in any portion of the course.
- Participants will **NOT** be permitted to ride without the following protective gear:
 - Over-the-ankle footwear
 - Long-sleeve shirt or jacket
 - Eye protection (glasses/sunglasses are permitted)
 - Full-fingered gloves (leather)
 - DOT approved motorcycle helmet
