

COOPERATIVE AGREEMENT

Fiscal Year 2017

Mine Safety Health Administration (MSHA)

Annual Refresher Training (ART) and New Miner Training (NMT)

This constitutes an agreement between the Nebraska Safety Center (NSC) at the University of Nebraska at Kearney and _____ herein after referred to as "Company".

The NSC will provide Annual Refresher Training, by competent persons (Part 46), to the "Company" for the sum of \$50.00 per attendee per session. New Miner Training will be available for a fee of \$200.00 per student (this is a two-day program). The Nebraska Safety Center must be listed in the Competent Persons list on Part 46. Multiple companies attending the same training session will be considered separate entities and will be billed accordingly. The maximum number of attendees per session will be 40.

Pre-registration is required for ALL classes. You must pre-register by either faxing your registration to (308) 865-8257, calling the office at 308-865-8258, or registering online. **If there are not sufficient attendees pre-registered by 5 business days prior to the class, the class will NOT be held. All individuals signed up at that time will be notified of the cancellation.**

A \$50.00 rescheduling fee will be charged if you are pre-registered and miss class. If you notify the Nebraska Safety Center prior to the class start, 8:00 a.m., there will be no rescheduling fee. A message can be left on voice mail at (308) 865-8258.

Training sessions will cover all subjects that are identified on the approved training plan of the Nebraska Safety Center. "Company" is responsible to ensure the accuracy of the training plan.

The NSC will provide "Company" with training certificates for issuance to attendees. The training forms will be delivered immediately after the class & prepared by the instructor. NSC employees or designated instructors will NOT sign the training certificate. The accuracy, distribution, compliance with training plans, and certification of the training record(s) rest solely with "Company". Training records will include the following statement for the appropriate signatures: *"False certification is punishable under section 110 (a) and (f) of the Federal Mine Safety and Health Act (P.L. 91-173 as amended by P.L. 95-164)."*

It is the responsibility of the Company to pre-register their attendees, determine compliance with their training plan, and to communicate dates, times, and locations to the participants. **The Company certifies that they have posted the agenda for their Part 46 Training Plan for review by their miners OR have reviewed the curriculum to ensure compliance with their Approved Training Plan.**
