***** General Information *****

- “Driver Reinstatement, Improvement, and Vehicle Education” is a 4-hour, Nebraska DMV-approved, driver improvement course emphasizing vehicle control, attitude, judgment, risk management, decision-making, and personal responsibility. Material from the Nebraska Driver’s Manual is also covered.
- Class times are Saturdays: 8:00 a.m. to 12:00 p.m. or Sundays: 1:00 p.m. to 5:00 p.m.
- You may bring an interpreter to class, if needed. Notify the Nebraska Safety Center if you are bringing an interpreter to class with you.
- If accommodations are needed, according to the ADA guidelines, please notify the Nebraska Safety Center at 308-865-8256.
- A performance-based, comprehensive examination is given at the end of class. Participants must score at least 80% to pass the class. If a score of at least 80% is not attained, the student has 30 days to re-test at no charge. After 30 days, the course fee will be re-assessed.
- **A \$50.00 rescheduling fee will be charged to any participant who fails to attend class as scheduled.**
- Class results will be processed by close of business the Wednesday following class.
